

REMUNERATION OF IDENTIFIED STAFF

DESCRIPTION OF THE CATEGORIES OF STAFF WHOSE PROFESSIONAL ACTIVITIES HAVE A MATERIAL IMPACT ON THE INSTITUTION'S RISK PROFILE, IRRESPECTIVE OF THE TYPE OF EMPLOYMENT RELATIONSHIP OF THE STAFF MEMBERS WHO PERFORM THOSE ACTIVITIES, WHETHER NORMAL EMPLOYEES OR MEMBERS OF THE SENIOR MANAGEMENT, AND THE NUMBER OF PEOPLE IDENTIFIED IN EACH OF THE CATEGORIES

Santander Group has implemented the quantitative and qualitative criteria provided in the regulation in order to determine the members of the identified staff and has further supplemented these criteria with additional internal criteria. The following persons generally qualify as identified staff based on this set of criteria:

Based on qualitative criteria - staff who work in a material business unit, such as:

- Members of the management, executive or supervisory committees.
- The first line of the unit.
- Heads of material business sub-units in the country or business area.
- Heads of risk, audit and compliance and the parties they report directly to, who effectively perform control functions.
- Heads of legal or tax advisory services, audit, budget, human resources, payments and technology and operations.
- Members of senior risk committees, managers with powers to approve risk proposals and the management responsible for making relevant risk proposals.
- Traders that can take major market risk positions.
- Members of the new products committee.

By quantitative criteria:

- Executives receiving total remuneration of over 500 thousand euros in 2019.
- Executive whose remuneration is in the highest 0.3% in the Group or in their country.
- Executives who in the past year earned more than the person with the lowest remuneration in the identified staff group, factoring in the business positions identified in the qualitative criteria

By internal criteria:

- Executives with significant responsibility for representing the Group at non-material units.
- Executives with a given level of responsibility over credit or market risk at certain nonmaterial units.
- Heads of business units with a banking license.

Additional criteria have also been defined to identify and classify the units to which the above criteria are applied. These criteria are based on simple and widely recognised parameters, such as capital and







gross income, and reflect the relative importance of each identified unit that has an impact on the risk profile of Santander Group.

Current legislation, best practices and market trends are taken into account when defining the proportionality standards. These apply to both the relative importance of the units, as well as the different degrees of responsibility of the positions occupied by the individuals, and facilitate its implementation.

According to these criteria, the identified staff comprised 1,359 executives across Santander Group at year-end 2019, accounting for approximately 0.69% of total staff.

PLANNED MEASURES TO ADJUST REMUNERATION IN THE CASE OF LOWER-THAN-EXPECTED PERFORMANCE

These measures fall within the scope of the variable remuneration system as a whole. Here, the basic principles of the remuneration policy for identified staff are as follows in 2020:

- Remuneration must be aligned with the interests of shareholders and be focused on long-term value creation, while remaining compatible with a rigorous risk management and with the company's long-term strategy, values and interests.
- 2. Fixed remuneration must represent a significant proportion of total compensation.
- Variable remuneration must compensate for performance in terms of the achievement of agreed goals, in line with the role and responsibilities of the individual and within the framework of prudent risk management.







- 4. The global remuneration package and the structure thereof must be competitive, in order to appeal to and retain professionals.
- 5. Conflicts of interest and discrimination must be avoided in decisions regarding remuneration.

The main characteristics of the variable remuneration policy for identified staff 2019 are as follows:

- In no case will variable remuneration be more than 200% of fixed remuneration or 100% of fixed remuneration in areas where no controls are run.
- Variable remuneration will usually comprise an incentive to be received partly in cash and partly in shares or other financial instruments for this purpose, while deferring collection of the incentive for a period of three to five years (and up to seven in the United Kingdom).
- Variable remuneration contains elements for measuring performance that are aligned with strategy and the long-term interests of shareholders. These elements, both in the short and—for certain categories—the long term, consider quantitative and qualitative criteria that reflect the entity's results, profitability, performance of capital, behaviour to customers and the quality of the services provided to them, risk management and compliance with regulations.
- It is subject to ex post deferred malus and clawback clauses, which are triggered in scenarios of deficient financial performance of either the bank as a whole or a division or specific area thereof or of the exposure generated by staff, with at least the following factors being taken into account:
 - Significant failures in risk management by the bank, or by a business or risk
 - The increase in capital requirements of an entity or business unit, unforeseen at the time the exposure was generated.
 - Regulatory sanctions or judicial sentences for events that could be attributable to the unit or the personnel responsible for them. Failure to comply with the entity's internal codes of conduct.
 - Irregular conduct, whether by individuals or groups. The negative effects
 deriving from the marketing of unsuitable products and the responsibilities of
 the people or bodies that took these decisions will be particularly considered.
- The percentages and terms of deferral are as follows:

The following criteria and processes regarding the consideration of present and future risks are taken into account in determining variable remuneration:

- Alignment of short and long-term quantitative and qualitative metrics with the Group's strategic objectives. These objectives and metrics cover the objectives in relation to employees, customers, shareholders and, hence, to society as a whole.
- The balance of quantitative and qualitative metrics.
- The inclusion of return on risk weighted assets as a basic metric for calculating variable remuneration, highlighting the importance of regulatory capital in obtaining results.
- The inclusion of qualitative factors to calculate bonuses to ensure a broad vision of performance, including key management aspects.
- The work done by the human resources committee in relation to the assessment of metrics. This committee includes members of senior management who are also responsible for different functions in the Group, including risk, internal audit, compliance, general secretariat and human resources, financial management and financial accounting and control. Their role in this committee consists of analysing quantitative metrics information, undertaking a qualitative analysis, and considering whether or not to apply exceptional adjustments. This analysis includes different matters related to risk, capital, liquidity, quality and recurrence of results, and other compliance and control matters.
- Payment in shares of 50% of the variable remuneration and deferral over three or five years of between 60% and 40% of the same.
- The obligation to hold the shares, whether delivered immediately or after a period of deferral, so that the beneficiaries cannot dispose of the shares until one year after the award.
- The malus clauses that condition payments of the deferred amount, whether in cash or shares, and the clawback option for variable remuneration up to the end of the withholding period corresponding to the final delivery of deferred shares.
- Corporate governance of the entire process, with the involvement of the board of directors as mentioned above, the composition and functions of the remuneration committee as described and the participation of the human resources committee with control functions.
- Variable remuneration limits. Variable remuneration extended to each executive in the identified staff for 2020 and any other variable remuneration corresponding to them may not exceed the applicable limits for variable remuneration.

(i) Number of affected persons: certain members of the Identified Staff (1,002 at 31 December 2019, as itemised in the Exhibit to the detailed recommendation prepared by the board of directors), and up to 50 additional beneficiaries, up to a total maximum of 1,052 persons. The beneficiaries of this resolution include the executive directors of Banco Santander and other employees of Banco Santander or other companies of the Group belonging to the "Identified Staff" or "Material Risk Takers", i.e. to categories with professional activities that have a significant impact on the risk profile of the Bank or of the Group, including senior executives, risk-taking employees or employees engaged in control functions, as well as other workers whose total remuneration places them within the same remuneration bracket as that of the





preceding categories. However, it is noted that the categories of personnel who engage in control duties are generally excluded from the scope of this resolution. The members of the Identified Staff have been selected pursuant to the standards established in Commission Delegated Regulation (EU) No 604/2014, of 4 March 2014, supplementing Directive 2013/36/EU of the European Parliament and of the Council with regard to regulatory technical standards with respect to qualitative and appropriate quantitative criteria to identify the categories of staff whose professional activities have a material impact on an institution's risk profile and those of the policy for determining the Group's Identified Staff.

- (ii) Authorisation. Without prejudice to the general provisions set forth in item Thirteen or to the powers of the board of directors in remuneration matters under the Bylaws and the rules and regulations of the board, the board of directors of the Bank is hereby authorised, to the extent required, to implement this resolution, with the power to elaborate, as necessary, on the content hereof and that of the agreements and other documents to be used or adapted for such purpose. Specifically, and merely by way of example, the board of directors shall have the following powers:
 - (a) To determine any modifications that should be made in the group of Identified Staff members that benefit from the resolution, within the maximum limit established by the shareholders at the general meeting, as well as the composition and amount of the fixed and variable components of the total remuneration of said persons.
 - (b) To approve the basic contents of the agreements and of such other supplementary documentation as may be necessary or appropriate.
 - (c) To approve all such notices and supplementary documentation as may be necessary or appropriate to file with the European Central Bank, the Bank of Spain or any other public or private entity.
 - (d) To take any action, carry out any procedure or make any statement before any public or private entity or agency to secure any required authorisation or verification.
 - (e) To interpret the foregoing resolutions, with powers to adapt them to the circumstances that may arise at any time without affecting their basic content, including any regulations or provisions or supervisory body recommendations that may prevent their implementation upon the terms approved or that require the adjustment thereof.
 - (f) In general, to take any actions and execute all such documents as may be necessary or appropriate.

The board of directors is authorised to delegate (with the power of substitution when appropriate) to the executive committee or to any director with delegated powers, those delegable powers granted pursuant to this resolution, all without prejudice to the representative powers that currently exist or may be granted in relation to this resolution.

The Company shall communicate the approval of this agreement to all Group companies engaging executives or employees belonging to the Identified Staff and who are beneficiaries of this resolution, without prejudice to the exercise by such of the Bank's subsidiaries as may be appropriate in each case of the powers they hold to implement the remuneration policy with respect to those executives and employees and, if applicable, to adjust such policy to regulations or to the requirements of competent





authorities in the respective jurisdiction, as well as to comply with the obligations that bind them for such purpose.
