However, the obligor's capacity to meet its financial commitments on the obligation is still strong. A minus (-) sign shows relative standing within the rating category.

In accordance with Moody's ratings definitions available on https://www.moody.com/sites/products/productattachments/ap075378_1_1408_ki.pdf, an obligation rated "Baa" is subject to moderate credit risk. It is considered medium grade and as such may possess speculative characteristics. The modifier 1 indicates that the obligation ranks in the higher end of its generic rating category.
